RECEIPT OF EMS CREDENTIALS

State certification cards for Advanced Emergency Medical Technician (AEMT) and Emergency Medical Technician (EMT) certification will be mailed via first-class mail once all requirements are met and confirmed.

Credentials for Emergency Medical Technician - Paramedic (EMT-P) accreditation and Mobile Intensive Care Nurse (MICN) authorization will be available for download once all requirements are met and confirmed.
